**Workshop Focuses on Practices and Programs to Conserve Wildlife Habitat**

The Hudson River Estuary Program and the Cornell University Cooperative Extension Biodiversity Program Work Team are co-hosting a workshop for private landowners interested in managing habitats for both common and rare wildlife and plant species at 9 am on Thurs. Nov. 10, 2005 at the New Paltz Town Hall, 1 Veterans Drive, Rt. 32 (N. Chestnut St). The workshop consists of indoor presentations and field tours of private and publicly owned habitats including a riparian zone, local wetland and a forested site. The goal is to provide workshop participants with on-site, hands-on examples of successful management practices undertaken by private and public landowners who wish to protect or enhance and conserve important habitats for wildlife. Riparian buffer restoration project in the Village of New Paltz on the Walkkill River. Ulster Co. Soil & Water Conservation District and the Natural Resource Conservation Service assisted the Village of New Paltz with project design and plantings.

**Site #2. Wetland restoration.**  
Private landowner who has used goats to control invasive vegetation and maintain early-succession habitats.  
**Site #3. Comprehensive forest management.**  
Private landowner who developed a Forest Stewardship Plan and acquired funding for management via the Forest Land Enhancement Program (FLEP); applied for DEC's Deer Management Assistance Permits to address deer damage concerns; plans to herbicide stands of "tree of heaven" and Norway maple; applied for the NYS Forest Tax Law 480-a; and has enrolled her land in a conservation easement.
